DRUG PROFILE

ULTOMIRIS

FDA approval date: 21 DECEMBER 2018

Active ingredient: ravulizumab-cwvz

Strength:

40 kg to less than 60 kg: Loading dose: 2400 mg IV

Maintenance dose: 3000 mg IV every 8 weeks starting 2 weeks after the loading dose

60 kg to less than 100 kg: **Loading dose:** 2700 mg IV

Maintenance dose: 3300 mg IV every 8 weeks starting 2 weeks after the loading dose

100 kg or greater:

Loading dose: 3000 mg IV

Dosage form: Parental

Route of administration: Intravenous

Mechanism of action: Monoclonal antibody that is a terminal complement inhibitor. It specifically binds to complement protein C5 with high affinity, thereby inhibiting cleavage to C5a (proinflammatory anaphylatoxin) and C5b (initiating subunit of the terminal complement complex [C5b-9]) and preventing the generation of the terminal complement complex C5b9 and inhibits terminal complement-mediated intravascular hemolysis in patients with PNH.

Adverse drug reaction: Ultomiris affects immune system. Increases the risk of infections
