Also, it is the intention of this new university to create well rounded professionals who can directly contribute to community service through social and professional extension activities.

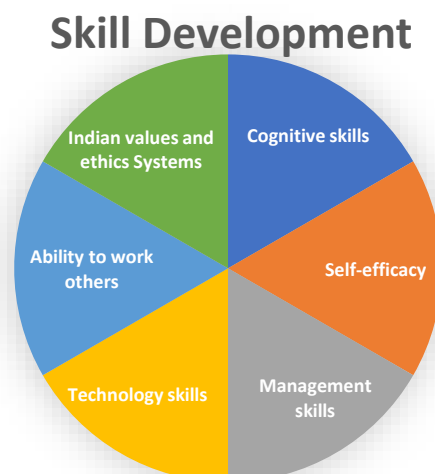

FACULTY RECRUITMENT PLAN

The University plans for requirement of competent and experienced faculty which depends on workload requirements as per the relevant statutory bodies. Preparing job description and person specification will be next major task followed by devising person specification and skills requirement for the roles. The recruitments will be done with the formation of relevant selection committees and followed by formal induction

Appointment/ Recruitment Plan of Senior Officers

The authorities and the officers of the universities - brief description of the appointment.

The Chancellor

Procedure for appointment:

The Chancellor shall be appointed by the Sponsoring body from a panel of three names selected by a Search Committee, by following such procedure and on such terms and conditions as may be prescribed. Search Committee shall be constituted by the Sponsoring body and consisting of a minimum of three members nominated from the Board of Management.

Pro-Chancellor:

Procedure for appointment:

The Sponsoring body of the University may also appoint a person as a Pro Chancellor, whose role would be limited to carrying out the tasks assigned to the Chancellor in these Regulations, when the latter is not available for carrying out the same. The Pro Chancellor, if so appointed, shall hold office for a period co-terminus with that of the Chancellor.

Vice Chancellor

Procedure for appointment:

The Vice Chancellor shall be appointed by the Chancellor from out of a panel of three persons recommended by the Search Committee and hold office for a term of three years or up to the age of 70 years whichever is earlier; Provided that after expiry of the term of three years, a person shall be eligible for re-appointment for another term of three years subject to the upper age limit of 70 years;



Provided further that a Vice Chancellor shall continue to hold office even after expiry of his term till a new Vice Chancellor takes charge of the office, but in any case, this period shall not exceed one year;

Pro Vice-Chancellor

Procedure for appointment:

- The post of the Pro Vice-Chancellor may be created in a University by the Board of Management;
- The Pro Vice-Chancellor shall be appointed by the Board of Management on the recommendation of the Vice-Chancellor.
- The Pro Vice-Chancellor shall hold office co-terminus with the office of the Vice-Chancellor
- The Pro Vice-Chancellor shall have the powers and duties as prescribed by Rules of the University.

Registrar

Procedure for appointment:

The appointment of the Registrar shall be made by the Chancellor in such manner as may be specified by the Statutes and The Registrar shall be directly responsible to the Vice-Chancellor and shall work under his direction

The Registrar shall be a whole-time salaried officer of the University and shall be appointed by the Board of Management on the recommendations of the Selection Committee consisting of the following: -

- Vice Chancellor – Chairperson;
- One nominee of the Chancellor;
- One nominee of the Board of Management; and,
- One expert, not being an employee of the University, to be appointed by the Board of Management.

Chief Finance and Accounts Officer

Procedure for appointment:

The appointment of the Chief Finance and Accounts Officer shall be made by the Chancellor in such manner as may be specified by the Statutes;



Controller of Examinations

Procedure for appointment:

The Controller of Examinations shall be appointed by the Board of Management.

Deans and Directors:

Procedure for appointment:

The Selection Committee chaired by the Vice Chancellor and other members are responsible for recruitment of the Deans and Directors of the University. They shall monitor the processes and systems through policies and procedures approved by the Board of Management periodically.

General Recruitment policy

Objective:

To recruit potential employees who have the relevant skills, qualifications and experience to make a positive, innovative contribution towards the development of the College.

Response Management: The applicants can apply for the posts advertised in both electronic mode and by mail. They shall be received and



a database must be created by the Central Recruitment Committee. These applications based on the discipline/Department will be separated and sent to the respective institutions/departments for short listing.

Short-listing: In this process applications are evaluated to determine the most suitable applicants for interview. These will be the applicants that most closely match the needs as defined in the person specification.

- If an applicant doesn't meet an essential criterion they should be discounted from the short list.
- The criteria for rejection must be demonstrated on the application form.
- Two or more people should shortlist applications, preferably from diverse backgrounds.
- Ideally to identify more candidates to invite to interview. This ensures candidates get fair hearings from alert and interested interviews.
- If an applicant has written anything on the application that discloses a specific request or recommendation, that must not be used in the decision-making process.
- The candidates can request to see any notes made about them during the short-listing stage.
- If the number of applicants meeting the essential criteria becomes difficult to manage, you can use the desirable criteria as a further screening method.

Arranging interviews:

- For Unsuccessful Applicants, Institution/Department in-charge shall send email and also call them over phone informing them that they have been unsuccessful.
- Applicant Feedback – If an unsuccessful applicant requests feedback constructive feedback as to why they were not short listed on this occasion shall be provided.

Conducting interview: Interviewing is the process of asking questions in order to gather evidence about a candidate's ability to fulfil the job role. An



interview is the compulsory element of the selection process. This enables an informed decision to be made about who is the best person for the job. It is also an opportunity for the candidate to learn more about the job and Institution.

Decision making: Following the interview and any other additional assessment methods that may have been incorporated into the decision-making process, panelists should begin discussing each individual's performance to decide whether they are suitable for recruitment. It is important to conduct this stage properly to ensure to make an objective and sound decision.

Avoiding bias: In decision making process the members of panel are all potentially susceptible to unconscious bias, stereotyping and distortion. To avoid unwittingly making any potentially discriminatory decisions wide consultations and unilateral decision has to be arrived.

Making the appointment

Formal offer: Establishment section of the Institution will then liaise with the successful candidate regarding the terms and conditions of employment, any contractual issues and their start date etc.

Induction: The Departmental/Faculty Induction should consist of pre-arrival activities (greetings procedures, physical arrangements, ICT services, induction activities and an induction pack).



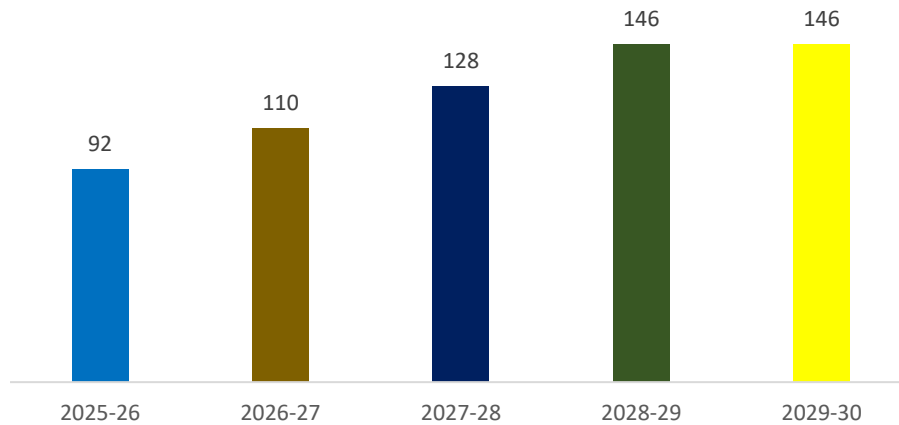

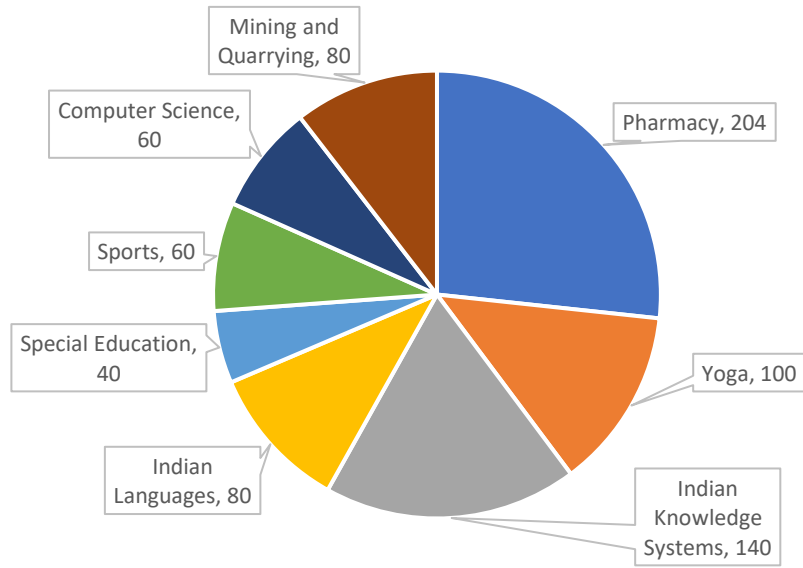

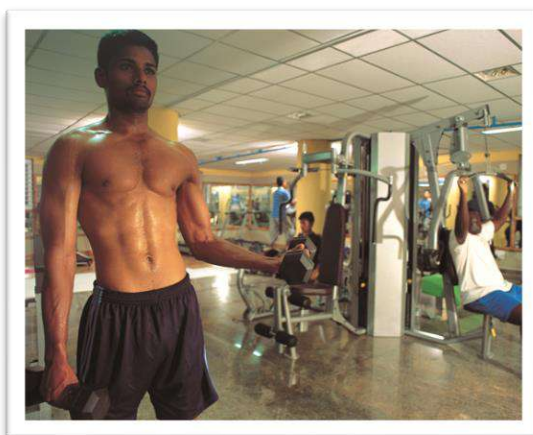


Sports and games

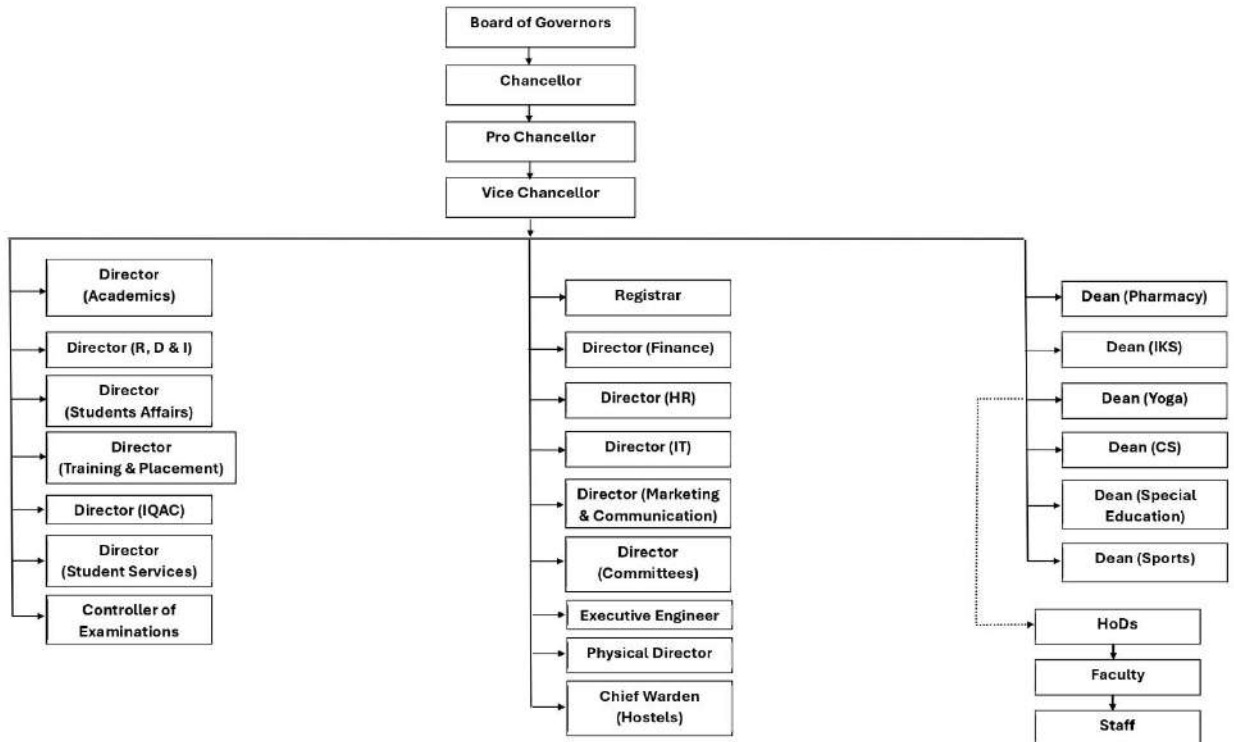

3. Membership:

(1) The Society is established for the purpose expressed in the Memorandum of Association. To implement the scheme proposed to be undertaken support from all the members is quite necessary.
