- e) to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein
- f) to exchange, on a reciprocal basis, students at Undergraduate, Graduate and Doctoral levels for limited periods of time for purpose of education and /or research.

**Sri Venkateswara College of Pharmacy (Autonomous), Chittoor and Seven Hills College of Pharmacy (Autonomous), Tirupati** further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

### B. Joint Sponsored Research, Development and Consulting

The terms and conditions for such participation will be worked out by mutual agreement between the two institutions.

### C. Exchange of Faculty, Scientists & Students

scientists from the two institutions. Specifically, institutions will encourage members of their faculties to undertake short visits to, or take up fixed-term visiting assignments at, each other's institution as per the existing norms. Terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, name of the concerned faculty member will be worked out between both the parties. Notwithstanding the above, **Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** and **Seven Hills College of Pharmacy (Autonomous), Tirupati** will examine ways to identify financial resources to fund international travel by their faculty/scientists/students.

#### **D. Exchange of Scientific and Technical Material**

**Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** and **Seven Hills College of Pharmacy (Autonomous), Tirupati** will exchange information on research and educational programmes and teaching/learning material and other literature relevant to their educational and research programmes. Further, both parties agree to explore ways to share teaching/learning material, and other relevant literature, while respecting each other's intellectual property and other rights.

#### **E. Joint Conferences, workshops and short-term courses**

**Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** and **Seven Hills College of Pharmacy (Autonomous), Tirupati** agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between the two institutes.

#### **F. Intellectual Property**

**Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** and **Seven Hills College of Pharmacy (Autonomous), Tirupati** agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

**G. Co-ordination**

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of

(a) **Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** or his nominee, Chairperson/Dean/Director/Principal, (b) **Principal, Seven Hills College of Pharmacy (Autonomous), Tirupati** or his/her nominee, (c) Programme coordinator from the side of **Sri Venkateswara College of Pharmacy (Autonomous), Chittoor**, and (d) Programme Coordinator from **Seven Hills College of Pharmacy (Autonomous), Tirupati** will periodically review and identify ways to strengthen cooperation between the two institutions.

**H. Tenure and Termination**

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for **five years**, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither **Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** and **Seven Hills College of Pharmacy (Autonomous), Tirupati** will be responsible for any losses, financial or otherwise, which the other institutions may suffer.

**I. Arbitration Clause**

Should there be a dispute relating to any aspect of academic cooperation, Principal, **Sri Venkateswara College of Pharmacy (Autonomous), Chittoor** and Principal, **Seven Hills College of Pharmacy (Autonomous), Tirupati** will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
